#### Taking is home – Florida District Board of Trustees

#### 1. Relationships - We are better together

- We have a lot in common with UU congregations in our association, even more so with those in our backyard! At your board meetings, make it a practice to talk about activities with other UU congregations.
- We need to be in relationship so we need to be accessible. Update your congregational contacts regularly through my.uua.org. If you have contact information on your Web page, make sure it is up to date.
- Respond to survey and discussion requests from Regional Advisory Council and other linkage outreach

#### 2. Elders - wise leaders of any age

- "Been there, done that." Probably every congregation has someone (or more than one) who has done just about everything there is to do. Talk with the Southern Region Congregational Life Staff and the new Elders Council about recognizing congregational Elders and helping them share their gifts with other UU congregations.
- Words have power. The word "Elder" has special meaning in the Cambridge Platform (one of the church leaders, not a teacher or preacher)
- From the Live Oak Project: An Elder is a person who is still growing, still a learner, still with potential and whose life continues to have within it promise for, and connection to the future. An Elder is still in pursuit of happiness, joy and pleasure, and her or his birthright to these remain intact. Moreover, an Elder is a person who deserves respect and honor and whose work it is to synthesize wisdom from long life experience and formulate this into a legacy for future generations.
- From the Elders FAQ: Congregations will recognize their own elders, who can serve at a congregational, cluster, regional or even national level. Elders can serve Unitarian Universalism on boards or councils, as consultant, teachers or small group leaders. They can represent the larger Association at ceremonial events, joining as one strong body to evangelize the South for Unitarian Universalism. A regional Council of Elders working in shared ministry with staff will help congregations recognize and celebrate elders and identify opportunities for service. Elderhood provides greater opportunities for our members to deepen their understanding of covenant and faith and enter into shared ministry.

#### 3. Clusters

- Are all about building relationships between congregations
- The Cambridge Platform states that churches should cooperate in several ways:

1. Mutual care and support for the good of the congregation and the advancement of the Faith.

2. Consulting with one another in regard to a church's experience, process, or practice.

- 3. Admonishing one another.
- 4. Sharing Elders and professional-staff

5. Giving recommendations to members who wish to move to another congregation.

- 6. Giving financial support to churches in need.
- 7. Sending Elders to the neighboring churches to introduce themselves.
- 8. Sending Elders to plant new churches.

Is our current cluster configuration optimal? How can we build new clusters?

#### 4. Southern Region

- One of five regions; the only one to vote to date to dissolve district governance

#### A Covenant for Doing Business Together

We will participate attentively.

We will respect the rules for the meeting.

We will show respect for our leaders.

We will show respect for all participants.

We will ask questions to clarify, not to make points.

We will speak for ourselves, not for others, using 'l' statements.

We will assume good intent and the sincerity of all.

We will balance strongly felt conviction with compassionate care for others. We will comport ourselves in keeping with the highest values of Unitarian Universalism.

#### **Rules of Procedure**

- All motions submitted by the District Board are admitted to the agenda and automatically "seconded."
- No item not previously admitted in accordance with the District's bylaws will be in order.
- Each motion may be debated for 10 minutes. At 10 minutes, the chair may ask for an extension of time, for an additional 10 minutes; a simple majority may affirm the request.
- Only credentialed delegates may speak before the body.
- Each speaker may speak for no more than 2 minutes.
- Each speaker must speak from the designated microphone, identifying themselves by name and the congregation they represent.
- The chair will alternate between pro and con speakers; ushers shall ask each potential speaker to stand to one side or another (if a single microphone) or line with the pro or con microphone.
- If there are no additional speakers at a con microphone, the chair may close debate and call for a vote.
- No one shall speak a second time until all those desiring to do so have spoken once.
- A motion to postpone consideration of an item is in order after 10 minutes; this is not debatable. The chair shall ask the question. A simple majority may affirm the motion.
- Motions of gratitude, thanks, or appreciation may be admitted to the agenda under new business.
