

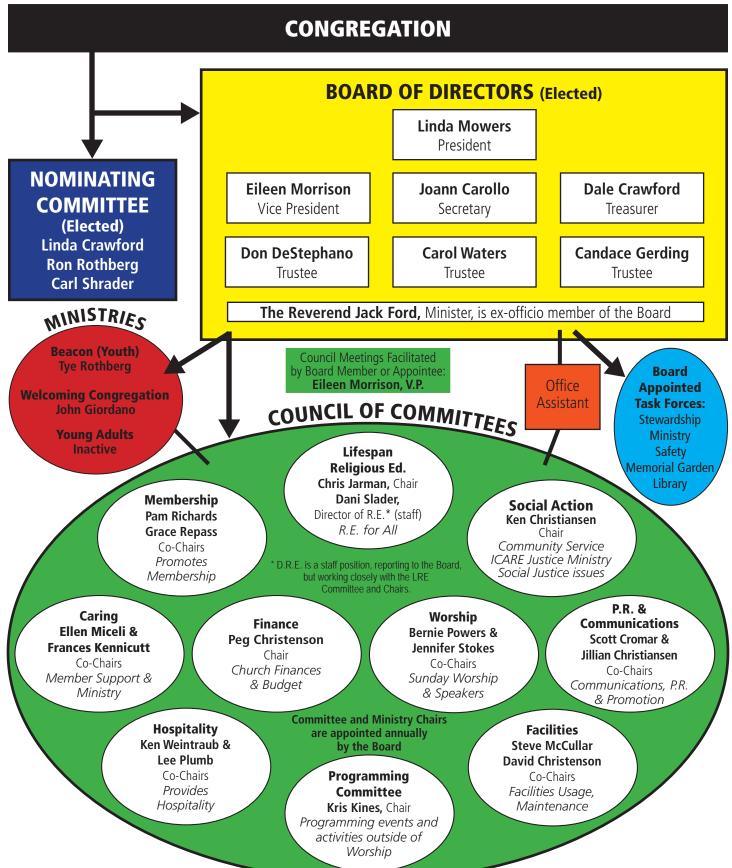

Buckman Bridge Unitarian Universalist Church Annual Meeting Minutes for Fiscal Year 2013-14

May 18, 2014

- 1. Call to Order Linda Mowers, President, called the meeting to order at 12:15 p.m.
- 2. Establish Quorum: 64 members in attendance (which is more than 40% of the 121 (48) needed for a super-quorum). Required votes for passing bylaws, 80% of 64, or 51 votes.
- 3. Approval of Minutes from 2013-14 Annual Meeting May 19, 2013. Motion from Kris Kines, seconded by Lynn Wadley. Motion passed.
- 4. President's Report: Linda Mowers presented the President's report and thanked the Board and the Council of Committees. She announced the Challenge Fund and a Town Hall Meeting for discussions on Monday, June 2, at 7PM, and Sunday, June 29, after the morning service.
- 5. Treasurer's Report: Dale Crawford, Treasurer, presented the Finance report, summarized the balance sheet and discussed the importance of supporting the church with a pledge. 23% of our members have not pledged.
- 6. Presentation of Proposed Fiscal Year 2014-2015 Budget: Peg Christenson, Finance Chair, presented the proposed budget. At present BBUUC is short \$4752 of meeting this year's budget.
 - a. Action on Proposed Budget A motion was made to accept the budget by Jen Glassman, seconded by Jeremy Ritzmann. Motion passed with one abstention.
- 7. Presentation of Slate of Officers, Trustees and Nominating Committee for Fiscal Year 2014-15: Carl Shrader presented the Slate of Officers, Trustees, and members of the Nominating Committee.

- a. Election of Officers, Trustees and Nominating Committee: A motion was made by Barry Mowers to accept the slate of nominees as presented, seconded by David Austin. Motion passed unanimously.
- 8. Presentation of Proposed Bylaw Changes: Several bylaw changes were considered. (Text available on pages 23, 24 of the Annual Report.)
- a. Action on Proposed Bylaw Changes: The two bylaw amendments failed to reach the 80% super quorum required to make the change to the bylaws. An amendment to move the bylaw addition to the Finance Policies & Procedures was defeated. Despite an apparent majority support for the bylaw addition, the required 40% super quorum was not met. All three proposed bylaw changes will be referred to a Bylaw Task Force for consideration, discussion, and revision over the coming year.
- 9. The meeting was adjourned by Linda Mowers, President, at 2PM.

President's Report: Fiscal Year 2014-2015

Our Annual Meeting each May signals the winding down of another fiscal year with an examination and appreciation of the activities and events that have taken place, as well as the health and vitality of our congregation. It's a time to draw one year to a close, and shift the direction of our focus to the year to come.

The past year has been chock full of challenges, community and relationship building, celebrations and milestones. Major decisions have been made that will affect the direction of our congregation, and we continue to create and maintain a solid organizational foundation that allows us to responsibly evolve.

I thank you for the opportunity to serve our church in the capacity of President these past two years. It is with mixed feelings that I end my last term on the Board, realizing what a truly great team we have become, but knowing that changes are good--both for me and for the congregation. Your Board this year has been harmonious, highly functional and passionate about our congregation. I have left each meeting feeling blessed to be surrounded by such wonderful, intelligent and committed colleagues, and have looked forward to each of our gatherings.

In addition to our regular Board meetings, we have had a number of special Executive Sessions and extra meetings to tackle special projects and goal setting. We held a Leadership Mini-retreat on a Saturday in September to define leaders' roles and provide some training and resources to help both the Board and the committee chairs along the way. The Board defined some goals at the beginning of the year to set our course, and we have achieved most of them. Some that we have fallen short on have at least been jump started for completion during the next administration, and other issues and actions have arisen that were not on our original radar. Our accomplishments have included:

- Created the following task forces:
 - Stewardship
 - Bylaws
 - Memorial Garden

- In the process of assembling and charging the following task forces to be active by June 30
 - Committee on the Ministry (including Right Relations)
 - Safety and Security
 - Library
- Revisit rental policies and pricing structure
- Define qualifications and privileges for membership status
- Recognize and celebrate our 25th anniversary
- Update, compile and publish a complete Policies and Procedures manual (underway, to be completed by June 30)
- Work with the Bylaw task force to address specific revisions regarding membership, term limit for Treasurer.
- Ensure fixes for bookkeeping bugs with Finance
- Revisit Office staff position after vacancy and work towards a new hire

In addition to these very specific goals, we also spent a good bit of our time together focusing on the fiscal health of our congregation, including stewardship, the budget process, and serving as stewards of our assets, security and organizational health.

Three important areas that have had some attention to research and development, but have been pushed into the next fiscal year are Strategic Planning, Mission/Vision work, Volunteer Coordination and Leadership Development. As past president, I look forward to providing continued support for these important areas, and will serve at the pleasure of your new Board to facilitate their progress.

I believe that our most important accomplishment this year has been building a foundation and facilitating the process for the congregation to make a decision to hire The Reverend Jack Ford as our minister. As most of you know, this was a very significant milestone for BBUUC that was reached only after a long process of financial management, fundraising, discussion and evaluation. We were so fortunate to have a very generous donor to jump-start the funding that has been growing this past year with more

generous contributions that have been matched and have been able to support the addition of professional ministry to our growing congregation.

We were able to bring Rev. Jack into the position the first of March to give him a bit of jump-start toward establishing his ministry. I believe that these past weeks have been instrumental in laying the groundwork for a successful first year of ministry for Rev. Jack. Next year, we will begin to see the wider effects of this shared ministry, and I am excited about the possibilities.

Most of the accomplishments that our congregation has realized are outlined in the committee and ministry reports contained in this document. We are so fortunate to have very dedicated and passionate leaders in our congregation--both on the Board and the Council. Our fabulous committee and ministry chairs, all volunteers, have worked hard this year to "make church happen," and many will continue to serve into fiscal year 2015-16. I am grateful for each of them! I plan to host a celebration on June 26th to honor all of the wonderful volunteers who are the lifeblood of our congregation, so I hope you will mark your calendars and watch for more details to come about this event.

In addition to the wonderful volunteers, I also want to recognize the fantastic efforts of our paid professional staff member, Director of Religious Education Dani Slader. Dani has such a great passion for our faith, and she carries that forward in her dedication and great attention to the children and youth of our congregation. We are fortunate to have Dani as our DRE, and I hope that we will be able to expand her support and resources in the coming year as she works to strengthen our Lifespan Religious Education program, which is an important foundation of this congregation, as well as its future.

I would also like to recognize and thank our former Office Administrator, Beth Christiansen, who had to leave us due to health issues back in December. Beth was an asset in our office, handling a variety of tasks and providing consistency as our "go-to" person. We hope that she continues to find improved health and happiness! Her absence has been obvious, but

we appreciate all of the Board and Council members, as well as our DRE, who have stepped in to take up those tasks until we are able to hire a new office staffer.

My thanks also go out to our wonderful Chaplains, Rev. Pat Ray and Karen Christiansen, who have been the backbone of our pastoral outreach for many years prior to bringing Rev. Ford on board. We are thankful for their important ministry and the help and presence that that they have offered to so many.

Thanks to all of the members and staff of our congregation, and to my leadership colleagues, for making my experience as President these past two years a wonderful one. Finally, special thanks to my wonderful and loving husband, Barry—as well as the rest of my fantastic family—for all of their love, support and understanding, taking a back seat so often to allow me to serve my congregation and our faith.

BBUUC Board Covenant for 2014-15

We, the designated BBUUC Board for the 2014—2015 fiscal year, have agreed to abide by the following covenant which binds us together as we represent the best interest of our church:

- We speak in one voice
- What is most important should be dealt with first
- We aim toward discussion, and at times, lively debate
- We aim toward consensus
- Respectful dissent is allowed
- Everyone's opinion matters
- Spirited language is allowed
- We agree to conduct business in a more efficient and timely manner by utilizing electronic communications to attend to matters between physical meetings.

Treasurer's Report: Fiscal Year 2014-2015

Summary: Our finances as of 31 March 2015 are in good shape, and we expect to end the fiscal year on a positive note. The increased giving among our congregants has strengthened the church's finances and allow us to undertake new activities and programs. Since February, 2011, when we moved into our current building, our finances have never been stronger. Major changes in our reporting of financial information have been made since our 2014 Annual Meeting. These changes have significantly improved the transparency of our finances and the clarity of our reporting.

The **Statement of Financial Position** as of 31 March 2015 is presented on the first page of the reports that follow. We have about \$39,000 of unrestricted cash on hand, in addition to the amount in restricted funds discussed in the next section. This amount of cash on hand represents a significant strengthening of the church's financial position, which will allow us to explore some urgent needs such as parking expansion. Our current assets have increased by about \$43,000, and our debt has decreased by about \$35,000. Details of the equity fund balances as of the end of March can be found in the report discussed in the next section.

The Statement of Financial Position by Restrictions is presented on the next two pages of the reports that follow. Our money is classified into one of four categories: Unrestricted, Board Designated Reserves, Temporarily Restricted, and Permanently Restricted. Only unrestricted money can be spent on any expense that the church may incur. Board Designated Reserve Funds contain unrestricted money that has been set aside by the Board for various contingencies, and are consistent with sound financial management practices. The money in restricted funds can be spent only for the purposes of the particular restricted fund. For instance, money in the Beacon Fund can only be spent on Beacon activities and needs. Money that is in Temporarily Restricted Funds is expected to be spent within a defined time. Money

in Permanently Restricted Funds is not expected to be spent, although any earnings from a permanently restricted fund may be spent in accordance with the policy of the particular fund.

Our current cash situation is very good. As stated earlier, we have about \$39,000 in unrestricted cash as of 31 March 2015. We have about \$88,000 in Board-designated reserved funds. In temporarily restricted funds, we have about \$108,000, mostly in our Mortgage Loan Contingency Fund, Ministerial Support Fund, and Challenge Fund. We have a little over \$10,000 in our Endowment funds, which are permanently restricted.

The **Statement of Financial Activities** as of 31 March 2015 is shown on the fourth page of the following reports. Our income from pledges is up by about \$17,000 compared with the same period of the previous fiscal year. Overall income so far this fiscal year is about \$93,000 in pledges paid and other donations, and about \$4,000 in income from rentals. We have so far written off about \$2,300 as uncollectible pledges. This total income of about \$97,000 has improved from the same period last fiscal year by nearly \$18,000. This \$97,000 in revenues exceeds our committee expenses of about \$65,000, giving us a book operating income of about \$32,000 through March of this year. In addition to this operating income, we have non-operating income of about \$5,000, most of which is not cash income. Our mortgage principal repayments further reduce the operating income by about \$20,000, giving us an effective cash income of about \$17,000 through the end of March.

The **Budget vs Actuals Report** for the current fiscal year is shown on the fifth page of the following reports. Our general donations lag last year, but this circumstance is probably because of our increased pledge and plate cash (anonymous) donations and our reclassification of some donations from general donations to pledgers' additional donations (the amount given by pledgers after meeting their stated pledge). We are running ahead of schedule on our

pledge revenue, but it is unlikely that this trend will hold up until the end of the fiscal year. We are running ahead of schedule on all of our other operating income, a trend that is likely to hold up until the end of the fiscal year. As usual, our committees continue to do an excellent job of managing expenses.

The church is in the process of moving most of its

banking from VyStar Credit Union to American Enterprise Bank. Over the past several years, there have been a series of shortcomings in VyStar's customer service and banking practices. The Finance Committee and the Board believe that our church will be better served at this new bank.

Motion to Authorize Purchase of Property to Expand Parking

The Board of this church recommends passage of the following motion:

This motion authorizes our church (BBUUC) to purchase two adjoining lots that will be used, as funds permit, for expanded parking or other church uses. The two lots are adjacent to each other and are immediately east of our property, abutting our current parking lot, beginning at the corner of Collins Road and Barcelona Avenue, and ending at the property line of the first house encountered south of Collins Road, on the west side of Barcelona Avenue. The purchase price shall not exceed \$25,000, and terms will be negotiated by the parking task force members (David Christenson, Dale Crawford, Don DeStephano and Steve McCullar), in consultation with the Church Board.

Proposed Revisions of the BYLAWS OF BUCKMAN BRIDGE UNITARIAN UNIVERSALIST CHURCH

(Adopted February 8, 2015)

Key to proposed revisions: Strike-though indicates deletions Underline indicates additions

Article VII. COMMITTEES:

Section 1. Standing Committees: Standing Committees of the Church are: Caring, Facilities, Finance, Lifespan Religious Education, Membership, Hospitality, Programming, Public Relations and Communications, Social Action, <u>Stewardship</u>, and Worship. These committees shall consist of three or more persons and shall meet at least one time in any ninety-day period. A standing committee may organize and appoint temporary subcommittees to assist with the work of that standing committee without the approval of the Board of Directors. Any such temporary subcommittee shall dissolve automatically at the end of each fiscal year, but may be reinstated by the standing committee in the new fiscal year. The Board of Directors retains the discretion to supervise and dissolve any temporary subcommittee created by a standing committee. The formation, reinstatement, and dissolution of any such temporary subcommittee shall be promptly recorded in the minutes of that standing committee.

Section 2. Additional Committees: The Board of Directors may organize and appoint temporary committees to assist with the work of the Board. Any such committee shall dissolve automatically at the end of each fiscal year unless affirmatively reinstated by the Board of Directors in the new fiscal year. The formation, reinstatement, and dissolution of any Board-appointed temporary committee shall be promptly recorded in the Board minutes.

Section 3. Financial Assistant: A member of the Finance Committee shall serve as financial assistant and shall receive and safely deposit all monies donated to the Church. He/she shall respect the confidentiality of all personal pledges and payments.

Section 4. <u>3.</u> **Council of Committees:** The committee chairs shall assemble as a Council of Committees at least once per quarter, presided over by the Board-appointed person, to network, review, and discuss church activities, and to identify any issues that would require support by the Board of Directors or Congregation.

- Adult and Multigenerational classes offered: Build Your Theology, Faith Like a River 1, Popcorn Theology, Facilitator training, Yom Kippur Observance, Water, Earth, and Us, Faith Like a River 2, Standing on the Side of Love, Bodi Day Observance, The Journey, Faith Like a River 3

Major Initiatives and Accomplishments:

- Scheduling and oversight of the Church's calendar. Together with the DRE, Admin, and chairs of Facilities & Hospitality committees, the requirements of each requests were determined and space was assigned.
 - The primary scheduling involved all of the regular events/meetings held in the Bldg. by the Committees, Board, Beacon and Religious Education Classes.
 - Secondary scheduling involved events like the Convocation, Cons, Gala's, Sleepovers, as well as Coffee Conversations, Reiki Classes, Movies, Art Appreciation, Blessing of the Animals and the occasional Fund Raiser.
 - The tertiary scheduling includes the calendaring what is planned off site; like Lunch Bunch, Circle Suppers, District Meetings, Pride Parade, Earth Day, etc.
- The Program Committee also reviewed Rental requests and scheduled regular Bldg. Rental after Board
 approved their contract. {We currently receive rental fees from the Free-Thought Society and Tai-Chi} Single
 event rentals are scheduled with committee discretion, according to the policies and after important maintenance requirements have been agreed to.
- The Program Committee also reviewed the success / failure of events in order to better serve the congregation in the future.

Challenges:

- Converted the Journey newsletter to a mobile-friendly format. (43% of survey respondents report that they now read the newsletter on a mobile device, up from essentially zero in May 2014.)
- Changed the production model of the newsletter to a more collaborative process, with a link shared by all event organizers for each month's newsletter.
- Increased use of hyperlinks in the Journey to provide easy access to deeper information on the subjects covered by the articles. (91% of survey respondents report following hyperlinks to drill down on subjects.)
- Refreshed the content on the BBUUC home page while retaining the color palette and font choices that had an 85% approval in our survey.
- Partnered with other BBUUC organizations to hold 5 successful outreach events.
- Press releases raised BBUUC's profile, with two mentions on local TV stations, and one extended interview with John Giordano.

Vital Signs (statistics):

- 345 Journey subscribers
 - 40 respondents to the most recent Journey satisfaction survey
 - 67% report a noticeable improvement in accuracy with the new collaborative production method.
- 80% of survey respondents report preferring a format designed for electronic devices. 9% prefer a paper-biased format. 11% have no preference.

- Organized a "Helping Our Neighbors" Community Outreach Program. Personal care and household items not covered by SNAP are collected every Sunday and brought directly to the Clothes Closet in Orange Park.
- Supported the Martin Luther King Day Parade in cooperation with the PR-Communications Committee.
- Planned for and staffed a BBUUC table at Jacksonville's Earth Day in cooperation with CUUPS, BEACON, and the PR-Communications Committee. We gave away 270 bird feeder kits assembled by BEACON plus another 100 or so kits assembled on the spot. And we gave away a lot of BBUUC literature.
- Supported UU Justice Florida and the national Move To Amend initiative by forwarding a motion to the Board for approval and inclusion in the Annual Meeting.

WHEREAS Unitarian Universalists affirm and promote the Seven Principles, and live our faith by living our principles, and
