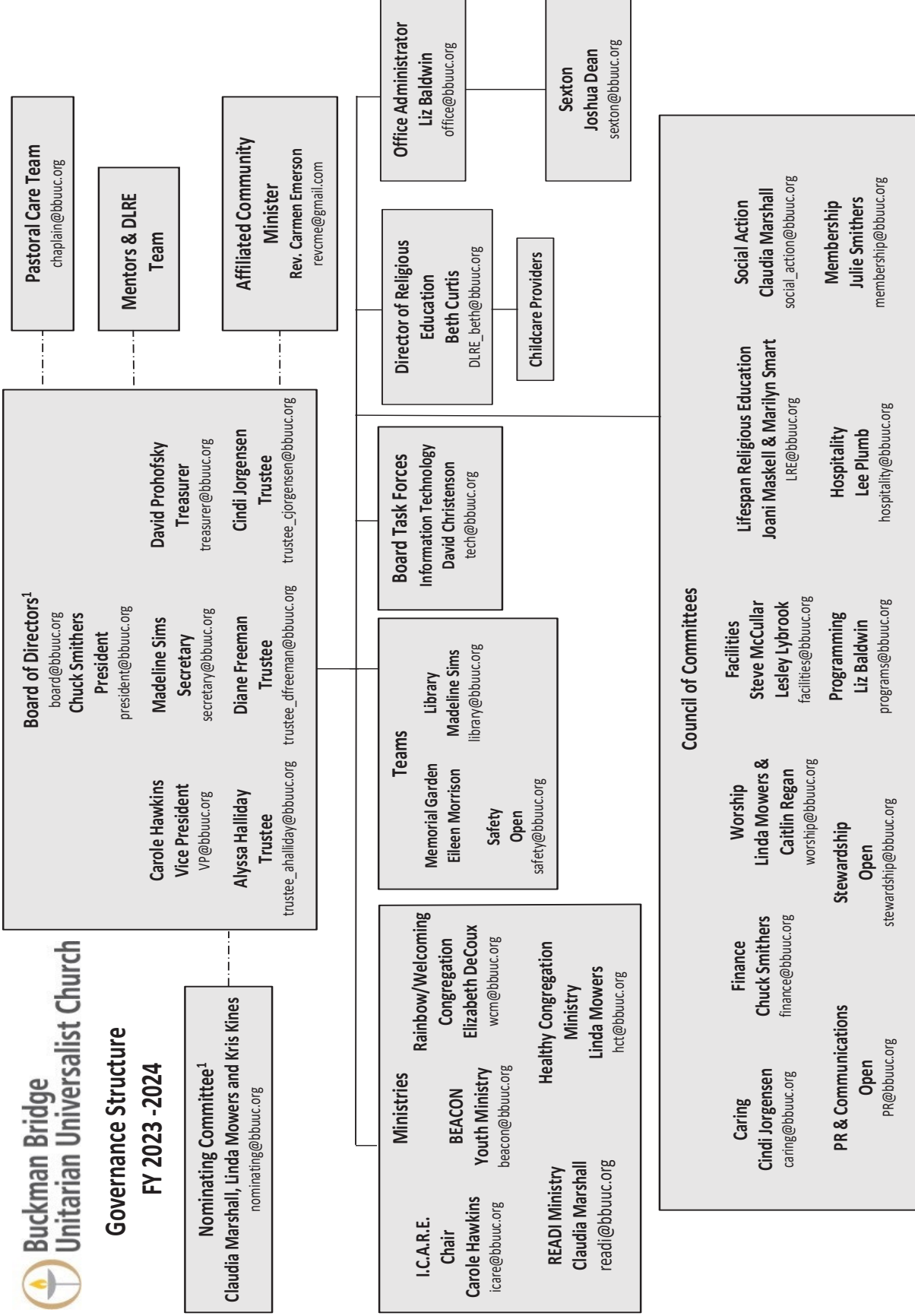

Call to Order

The annual meeting of Buckman Bridge Unitarian Universalist Church was held on May 21, 2023. It began at 12:04 pm and was presided over by Board President Chuck Smithers, with Madeline Sims as Secretary.

Establish Quorum

There are currently 135 Members. The quorum for this meeting is 25% or 34 Members. There were 14 proxies and 51 Members in attendance. The quorum was met.

Approval of minutes

The minutes from the May 22, 2022 meeting were distributed to the congregation in the meeting notice. The floor was open for any member to offer corrections. Since there were no corrections proposed, the minutes were approved as distributed by unanimous consent.

President's Report presented by Chuck Smithers, Board President

READI Ministry Resolution

The proposed resolution was distributed to the congregation in the meeting notice and introduced in the meeting by Rev. Carmen Emerson and read by Mike Ludwick. No questions or discussion.

Voting was done by raising voting cards. The resolution was approved unanimously.

Leadership Development Committee nominations

On behalf of the Leadership Development Committee, Chuck Smithers presented the following nominations for the Board of Directors:

- President – Chuck Smithers
- Vice President – Carole Hawkins
- Treasurer – Jason Chapple
- Secretary – Madeline Sims
- Trustees – Molly Brady and Cindi Jorgensen

Elections

All elections were uncontested, so bylaws specify that elections be done by acclamation.

There is one open position on the Leadership Development Committee. The bylaws specify opening the floor for nominations. Heather Chapple volunteered but since she is an employee, she cannot serve on the Leadership Development Committee. There were no other nominations. At the beginning of the next fiscal year, there will be 1 vacancy in the Leadership Development Committee that can be filled by a Board of Directors appointment.

Treasurer's Report presented by Pam Richards, Board Treasurer

Budget

- The proposed budget for fiscal year 2023-2024 was distributed to the congregation in the meeting notice.
- The Finance Committee Chair, Peg Christenson, presented the proposed budget. There is a \$34K increase from last year. In the future, the committee might include a report on the change in each budget line item.
- Kris Kines motioned to approve the 2023 – 2024 budget as submitted, seconded by Molly Brady. Opened the floor for questions: no questions.
- Voting was done by raising voting cards. The budget was approved overwhelmingly.
- The congregation gave Peg a round of applause for her years of service as Finance Chair.

Bylaws

David Christenson presented a total of 7 Bylaws changes that were detailed in the annual report. He reviewed that per existing bylaws, a supermajority is required for changes to these Bylaws. A supermajority is when the number of yea votes is equal to or greater than 4 times the number of nay votes. Abstentions do not count as a vote but can be used to ensure quorum is still met.

Proposed Bylaws Change #1: Changes Articles VIII, IX and X

Leadership Development => Nominating

David made a motion to approve proposed bylaws change #1, as approved by the Board and as written in the meeting notice, seconded by Kris Kines. No questions or discussion. Voting was done via electronic means. There were 62 yays and 1 nay. Motion passed with a 98.4% vote.

Proposed Bylaws Change #2: Changes Article XVI Amendments

Clerical notations, such as updating table of contents and renumbering of articles and sections.

David made a motion to approve proposed bylaws change #2, as approved by the Board and as written in the meeting notice, seconded by Linda Mowers. No questions or discussion. Voting was done via electronic means. There were 64 yays and 0 nays. Motion passed with a 100% vote.

Proposed Bylaws Change #3: Changes Articles VI, VII, and XI

Governing structure more flexible

David made a motion to approve proposed bylaws change #3, as approved by the Board and as written in the meeting notice, seconded by Nina Hemmelgarn.

Discussion: Mark Yount proposed an amendment to this motion to replace the last sentence on dissolving committees with the following sentence: "The Board shall provide timely prior notification to Leadership Council, which shall conduct an advisory vote, which shall be reported to the Board prior to the meeting at which the dissolution will be voted." Mark further clarified that the Leadership Council is our current Council.

Chuck asked for someone to second the proposed amendment to the motion, which was seconded by Rev. Carmen Emerson. Voting was done via electronic means. There were 45 yays and 19 nays. Motion passed with a 70.3% vote since Mark's amended motion only needs a majority to pass and not a supermajority.

David made his motion again, with Mark's amendment, seconded by Carole Hawkins. Further discussion was had on the merits of the proposal with the recent amendment and the desire to keep the bylaws simple. Voting was done via electronic means. There were 26 yays and 31 nays. Motion failed with a 45.6% vote.

A point of order was made regarding whether we could re-vote on the original proposal since the amended proposal failed. The parliamentarian confirmed we could. David re-made his original motion to proposed bylaws change #3, as approved by the Board and as written in the meeting notice, seconded by Mike Bernos. Voting was done via electronic means. There were 57 yays and 4 nays. Motion passed with a 93.4% vote.

Proposed Bylaws Change #4: Article XV Minister

Called Minister

David made a motion to approve proposed bylaws change #4, as approved by the Board and as written in the meeting notice, seconded by Tara.

Discussion: Mark Yount made the following motion to amend the current proposal to Section 2, seconded by Carole Hawkins:

- Add the following bullet point after the first one:
A membership vote of preapproval to hire a contract minister is limited to a one-year contract, unless otherwise specified in the meeting notice and motion wording. The Board may extend the term of that contract up to an additional three months. Any continuation, extension, renewal, or replacement of a contract minister beyond 15 months must be approved by the Board, and by membership at a meeting whose notice specifies this vote.
- Add the following to the end of the current second bullet:
Continuation, extension or renewal of a contract for a minister actively under contract with BBUUC does not require a Ministerial Search Committee. In the event a contract minister preapproved by the congregation vacates that position, the Ministerial Search Committee may hire a different contract minister subject to the same terms and conditions as the previous vote of the membership.

Discussion: Concerns were raised that this amended proposal could imply that the congregation does not trust ministers. In addition, with this amendment, we would not be able to hire any minister that needs to complete two years as part of their developmental plan to achieve fellowship status. The contract we have with our next minister could include these constraints, but we do not need to include them in the bylaws. Voting was done via electronic means. There were 2 yays and 57 nays. Vote to amend the proposal failed with a 3.4% vote.

With the vote on the amended proposal #4 failing, a vote on the original proposal was held. Voting was done via electronic means. There were 60 yays and 3 nays. Motion passed with a 95.2% vote.

Proposed Bylaws Change #5: Article V Membership, Section 1

Various Membership Updates

David made a motion to approve proposed bylaws change #5, as approved by the Board and as written in the meeting notice, seconded by Kris Kines.

Discussion: Question was raised whether there was always a requirement to make a financial contribution David answered it has been in there for quite a while.

Voting was done via electronic means. There were 62 yays and 0 nays. Motion passed with a 100% vote.

Proposed Bylaws Change #6: Article V Membership, Section 2

Annual Update to Membership Roster

David made a motion to approve proposed bylaws change #6, as approved by the Board and as written in the meeting notice, seconded by Nina Hemmelgarn.

Discussion: Important to go through this process of keeping the membership list current as it skews quorum and the reported number to the UUA.

Voting was done via electronic means. There were 63 yays and 0 nays. Motion passed with a 100% vote.

Proposed Bylaws Change #7: Article V Membership, add section 6 to Article V

Revoking Membership

David made a motion to approve proposed bylaws change #7, as approved by the Board and as written in the meeting notice, seconded by Joani Maskell.

Discussion: Molly Brady made the following motion to amend the current proposal to Article V, Section 6, seconded by Carl Moody.

- Add the following after the first numbered sentence:
 - a) Prior to a final decision, the Board must:
 - i. Notify the Member in writing of their intent to revoke their membership and reasons for the revocation.
 - ii. Provide the Member with an opportunity to present their position to the Board.

Discussion: Very lengthy discussion was had over the original proposal and Molly's amendment to the proposal. Those who spoke in favor of Molly's proposal desired having a due process for revoking anyone's membership and that any removal of a Member should be done with extreme caution and care. The Board would still be empowered to immediately remove a Member over serious violations. Those who spoke in favor of David's original proposal stated that the Board would not arbitrarily remove Members and that the congregation should trust the democratically elected Board. The original proposal states that a reason for revoking membership must be documented and provided to the Member. Members could still ask to be reinstated. A concern was raised regarding if what is shared with Member about why they have their membership revoked would be shared widely — would this infringe upon confidentiality, especially if the Healthy Congregation Ministry was involved? Additional discussion was had regarding whether Molly's proposed amendment should be in a Board policy or the Bylaws. Those in favor of Molly's amended proposal feel the process in revoking membership is so important it should be in the bylaws rather than a Board policy that could change each year. A question was raised that if we revoke membership, could that person still attend service? The answer is yes: they could attend service but not vote.

A vote on Molly's proposed amendment was held. Voting was done via electronic means. There were 40 yays and 18 nays. Motion to amend the proposal passed with a 69% vote.

After additional discussion, voting was held on the amended proposal. Voting was done via electronic means. There were 56 yays and 1 nay. Motion passed with a 98.2% vote.

Words from the Floor

Madeline Sims thanked Pam Richards and Peg Christenson for their hard work over the years overseeing the church's finances.

President's Report: Fiscal Year 2023-2024

It has been a great honor to serve as the President of BBUUC for the past two years and to be able to work closely with your BBUUC Board. The Board had another busy year beginning with a planning retreat last August. At the retreat we went through an in-depth discussion of "What we do well" and "What we could do better." We determined the areas we wanted to concentrate on over this fiscal year. One significant item that came out of the retreat was the need to increase our focus on clear and timely communications provided to the congregation and among the various program areas. I want to thank the members of the Board for their dedication to fulfilling their responsibilities this year.

I am very happy to report that we have just completed another successful Stewardship Campaign. We have heard back from about 55% of our members. At this point we have pledges of \$128,480, which is somewhat short of our overall goal. The generosity of our members and friends continues to be amazing and a great testament to the support of the programs and services they value. We will have the final tally to report at the Annual Meeting along with the budget for next fiscal year, which will be up for approval by the congregation. In addition, I want to thank all of you who returned a Gifts of Self Survey. This is another key element of Stewardship and has given us a really good source of volunteers and information about their interests and talents.

Our membership numbers have grown nicely this year. As of the end of April we have 147 members, which is an increase of 12 from last year at this time. The Learn About Us classes have graduated 17 during the period July 2023 through March 2024.

I want to applaud the work of the Worship Committee for a job well done again this year. The services Worship plans and executes for us each week are the best I have experienced on my faith journey. Because we are a lay-led church, the services organized and presented by Worship each week, along with the Lifespan Religious Education program, are fundamental to a Beloved Community.

Lifespan Religious Education program has enjoyed a successful and very active year. Our Director of LRE and the LRE Committee have worked hard to offer a wide variety of educational and fun opportunities for our children, youth, and adults. New volunteers are always welcome to serve as door minders or as teachers/facilitators.

Our focus on justice work is shown through the efforts of the READI Ministry, the ICARE Ministry, and the Rainbow Welcoming Ministry in continuing to do the hard work of keeping those in our community, and even the broader community, who are marginalized and discriminated against in the forefront of our minds. They provide us with meaningful communications, discussion groups, and resources as a way of including as many in the congregations as possible in this work. We were successful again this year in being certified as a Welcoming Congregation by the UUA and we had 47 of our members at the ICARE Nehemiah Assembly last month.

I am sure it is clear from all the efforts mentioned that our volunteers and staff are an integral part of the lifeblood of our organization. Whenever you get a chance, say thanks to them for all they do – I could not have done my job without them.

I look forward to the coming year to see what new and exciting things await us at BBUUC. I will end by saying I count on seeing you each Sunday and at the many meaningful events our church sponsors during the year.

Affiliated Community Minister's Report: Fiscal Year 2023-2024

I remain in covenant with BBUUC as your Affiliated Community Minister. As part of our Covenant, as well as professional ministry ethical guidelines, I also remain in good standing with the UU Ministers' Association (UUMA) and in full fellowship with the UUA's Ministerial Fellowship Committee.

Preaching – I've been in the BBUUC pulpit 9 times this year for our "Second Sunday Spirit in Practice" series about spiritual practices that help us to deepen our UU spirituality, identity, ethics, and faith (covenantal understandings). I also offered the 2023 Christmas Eve service at BBUUC. I will continue to work with the Worship Committee about possible services to offer in the coming year. I also guest-preached twice at the New Vision UCC church in Yulee, Florida, a UU-friendly congregation who often has UUs from Nassau County in their Sunday morning worship services.

Mentoring: Healthy Congregation Ministry – I continue to work with this group of dedicated and skilled UUs who love BBUUC and want all good and healthy things for our beloved community. Their commitment to ongoing learning is inspiring. We are fortunate to have spiritually and emotionally mature people to help us expand our knowledge of covenant and shepherd our efforts to navigate covenantal relationships at tender or conflicting moments.

READI Ministry – I continue to be a part of the READI (Race, Equity, Accessibility, Diversity & Inclusion) Ministry team as we navigate internal landscapes, exploring our experiences and deepening our understandings of AR/AO/MC work (Anti-Racism, Anti-Oppression and Multiculturalism), all in support of outward actions towards multicultural and intercultural equity.

Community Ministry – In January I accepted a promotion from Lead Chaplain at Baptist Nassau Medical Center in Fernandina Beach to Spiritual Support Services Coordinator for the Baptist Health System; I am now working out of the main hospital in downtown Jacksonville. I continue to serve as an on-call chaplain for Baptist Nassau. Two major pieces of my new portfolio have been (1) launching the new Bereavement Service Line within BHS, beginning with bereavement support groups for staff members; and (2) planning our 2024 Restorative Chaplaincy Conference for September 2024, a regional conference for chaplains and other clinical providers in healthcare systems. I performed one inter-faith wedding for staff members of Baptist Nassau. I wrote the liturgy for and coordinated the virtual Easter Service for BHS.

Denomination at Large – I will be attending General Assembly in June 2024 as a BBUUC delegate, and look forward to sharing news of this important GA with you.

Continuing Education – In April I will be in Colorado for a week, attending bereavement training at the Center for Loss & Life Transitions, a continuing education part of my professional work in chaplaincy for BHS. My on-call and coordinator roles often keep me away from BBUUC on Sunday mornings, but I remain a committed member and am glad to be in covenant with you in representing Unitarian Universalism in the larger community.

(limit to two consecutive terms)

The **President** presides over Church meetings, presides over Board of Directors meetings, is responsible for the integrity of the decision-making process, and ensures that the duties of the Board are carried out as specified in policies and these Bylaws.

It is an honor to be nominated to serve as Board President of BBUUC. My connection to this church has been the focus of my life, second only to family, since I joined six years ago.

My "conversion" to Unitarian Universalism happened twelve years ago, when I first attended a UU service and realized that the community engagement – on a local and nationwide level – supported my own ideas about the world. I quickly became involved, and was the Chairperson of the Unitarian Universalist Fellowship of Vero Beach (UUFVB) Council for four years, and sat on the nominating committee for two years. I was also the co-runner of our very successful fair trade shop.

My professional life included nursing and teaching in a high school. Both of these professions are people-centered. I was also allowed to use my leadership skills and knowledge of our school system and cohorts involved by chairing our committee to renew our accreditation. Perhaps my most notable leadership accomplishment there was chairing the School Advisory Committee for four years, which brought together 25 various stakeholders involved in our school, which had 3,200 students.

In the community, I have served as a poll watcher for the last four presidential elections and have been an active Guardian ad Litem for six years.

I consider BBUUC my community. I am joyous every Sunday to be with our members and guests. We are a haven for like-minded folks who want to be partners in life – whether it be for Sunday services, giving support during challenging times, or forging friendships. We are a group that depends on the talents and work of many to keep us a healthy congregation, with the goal of celebrating what we have in common and working through our differences, all with respect and kindness. I have served as chair of Membership, and presently I serve as Chairperson of Caring Committee, a position that is authentic for me. Again – people-centered, I have been the lead person for social events and social action activities, and I presently help when possible with RE.

If chosen to serve, I promise that I will do whatever I can to forge relationships, rely on experts on our team, facilitate discussions to find consensus, manage when necessary, and lead responsibly. Our Buckman Bridge Unitarian Universalist Church is, in many ways, my home away from home. In my capacity as Chair of RWM, I have served on BBUUC’s Council since 2020.

Another area of my participation has been as a member of the Worship Committee. I regularly serve as a Worship Leader for our Sunday services. I have given the sermon on several occasions; my sermon “Seeing Animals” was selected by the Unitarian Universalist Animal Ministry to receive the Schweitzer Prize for the best sermon on our responsibilities to animals.

I completed my training with the Association for Veterinary Pastoral Education in 2022 and became a Certified Animal Chaplain. I have served as BBUUC’s Animal Chaplain since then, providing animal-related spiritual care.

Nominating Committee Members Nurture the long-term health and vitality of the congregation's leadership pool, identify potential leaders, identify support resources for leaders, and perform other duties as specified in these Bylaws.

I was born in St. Louis, Missouri. My husband was a fallen away Catholic and I was a fallen away Jew. We joined the First Unitarian Church of St. Louis in 1979 while we were pregnant with our first child. In my late husband's words: "We needed a religion that our children could ultimately reject." In truth the UU faith felt comfortable the moment we walked in the door. I immediately became active in their Religious Education program.

In 1987, my husband was asked to open a branch office in Jacksonville, Florida for the architectural firm that he worked for and we left family and friends and made a new start. We joined the Unitarian Universalist Church of Jacksonville that year, but to my disappointment children's religious education was a low priority. I then became active in selecting a new minister as the existing one was retiring and fortunately the new minister saw the need for a religious education director and the program was re-born. Once our youngest graduated from high school we felt that our job was done (and yes, our children ultimately fell away from the UU faith) and we quietly left the church.

I decided that I needed a religious home once again in 2018 and joined the BBUUC. It was an excellent decision and I am so grateful for this church and the congregation, as I feel that I have found a spiritual home here.

Treasurer's Report to Congregation as of March 31, 2024

Highlights

We owe a tremendous vote of thanks to the volunteers who recently passed on the reins of our financial management. Pam Richards and Peg Christenson did yeoman's service for many years. To date, we seem to be managing the transition to new leaders without material error, and I for one am grateful for the patience and trust that has been shown to me.

BBUUC remains in a strong financial position. We have no debt. Bank accounts plus investments fund all Reserves and Restricted Net Assets with cash.

We have restored the Operating Reserve to the Board's established balance of \$60,000. Our spending has not matched our growth in donations, and we should have a surplus at year end to further secure our future by building our CR&R (Capital Repair and Replacement) Reserve towards our goal.

We have streamlined some of our administrative processes, to ease the burden on our volunteers. Primarily, we have eliminated some of the smaller dedicated funds, recognizing that Board approvals required for the use of those accounts made the separate treatment unnecessary.

Statement of Financial Position as of Mar. 31, 2024 vs Mar. 31, 2023 (Prior Year)

Bank Accounts increased by over \$40,000 to ending balance \$219,315. Other Current Assets increased \$70,001 to ending balance \$325,322. Fixed Assets are unchanged, and Long Term Liabilities are zero.

\$17,400 was returned to the Capital Repair and Replacement Reserve replacing approximately 40% of the amount withdrawn last year, leaving balance of \$109,348.

The Congregational Growth and Development Reserve was not drawn on, leaving the balance at \$90,027.

\$1,299 was disbursed from the Emergency Caring Fund, leaving a balance of \$5,541.

Endowment Net Assets increased \$33,349 due to recovery of the financial markets.

Statement of Financial Activity July 1, 2023 to Mar. 31, 2024 vs Prior Year to Date

Total Revenue is approximately \$21,000 higher than last year due to ~\$25,000 increased contributions from pledgers, and a fifty percent increase in plate cash. This offset a decline in general donations of approximately ~\$1,500. Fundraising increased by approximately \$500 to \$4,499.

Treasurer's Report to Congregation as of March 31, 2024 (Continued)

Total Operating Expenses are down more than \$8,200. We decreased spending by more than \$2,600 for administration, and \$10,200 in payroll costs due to not having a minister. We faced increasing costs in Facilities where Board approved purchase of the AED (automated external defibrillator) and the extra tree trimming and yard cleanup costs of \$2,200 and \$2,500, respectively. There was a decrease in Finance expense for insurance of approximately \$1,900 due to the inability to procure hail and wind damage protection, and higher expenses for Lifespan Religious Education (LRE).

Budget vs. Actual Expenditures as of March 31, 2024

Total Revenue is 83% of budget for 75% of the year.

Total Operating Expenses are 65% of budget for 75% of the year.

- Replaced grab bars over tanks in both handicap stalls that had rusted due to chlorine from the water.

- Hall entry touchpad needs to be replaced.

- In the coming year, we plan to conduct additional training opportunities on healthy congregation practices for BBUUC leaders and members. We are currently planning a Saturday workshop (date to be determined) on "Healthy Leadership and Managing Conflict." Topics for the workshop include:
 - Triangulation
 - Differentiated Leadership (*Maintaining a non-anxious presence in the face of anxious others.*)
 - Family Systems
 - Healthy Boundaries
 - Leadership Nuts and Bolts: Healthy Meetings, Effective Minutes, Finding and Nurturing Volunteers.

Major Initiatives and Accomplishments:

- Training is ongoing for the members of this Ministry. This year, we began the UU Institute's training for Healthy Congregation/Right Relationship teams entitled: "Tending Covenant: Training for Right Relationship Teams," which will be completed this summer. It contains nine robust modules that include videos, reading, and reflection. We meet after each module for activities, discussion, and role-play. The topics covered include Covenant as group spiritual practice, knowing ourselves, boundaries, shaping restorative culture, support and accountability, trauma, team building, and congregational resources.
- Members of our Ministry have met privately with members of the congregation, as requested, to facilitate resolution or reconciliation of conflicts.

Mission Statement (or purpose): BBUUC is one of 38 congregations that collaborate in Jacksonville's Interfaith Coalition for Action, Reconciliation and Empowerment (ICARE). Through direct action, we use the power of organized people to hold public officials accountable for issues of justice and fairness affecting our community.

Vital Signs:

- BBUUC ICARE Team Leaders held 4 House Meetings attended by 30 BBUUC members and friends in September and October. Twenty-one persons became BBUUC Justice Ministry Network Members.
- 5 BBUUC Network Members attended the Community Problems Assembly Oct. 30.
- 3 attended the ICARE Research Kickoff Dec. 4, and 4 became research committee members.
- 11 attended the BBUUC Justice Ministry meeting Feb. 24.
- 9 attended the citywide Rally March 4.
- Rev. Adam Gray, lead pastor of Riverside Church at Park & King, gave a sermon *And Never Give Up* April 7.
- 47 BBUUC members, friends and family attended the Nehemiah Action Assembly April 15. 3 BBUUC members served in leadership roles.

ICARE Actions in 2023-24:

- This year's Nehemiah Action addressed three issues:
 - **Care for Creation**, to prepare for the impacts of sea level rise by supporting a countywide flood vulnerability assessment.
 - **Mental Health Response**, to de-escalate and divert people suffering from a mental health crisis into treatment, rather than jail.
 - **Group Violence Intervention**, to reduce homicides by reaching out with social services to people in gangs, but also promising enforcement for those who keep offending.
- ICARE held three press conferences, a prayer vigil, and a phone campaign to the Jacksonville Sheriff's Office, calling on Sheriff T.K. Waters to engage with us on the issues of group violence intervention and mental health response. Thirteen BBUUC justice ministry network members participated in these extra actions.
- **Issue Won! Care for Creation.** Jacksonville Chief Resilience Officer Anne Coglianese reported the city this year completed its flood vulnerability assessment. This shows the people, land and infrastructure that would be impacted by increased flooding due to sea level rise and gives the city new tools to plan for the future. Any city that completes a flood vulnerability assessment qualifies to compete for \$100 million in annual funding from the Florida Department of Environmental Protection for resilience projects.

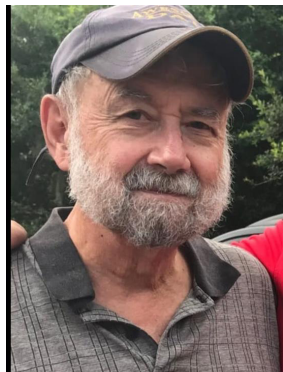
Major Initiatives and Accomplishments:

In Memoriam



Arthur David Johnson **September 23, 1942 — September 16, 2023**

David Johnson, 80, died peacefully in his sleep on Saturday, September 16, 2023 in Jacksonville, FL. He is survived by Joyce Grader Johnson, his wife of 59 years; siblings Peter and Odette; sons Tim and Phil; daughters-in-law Silvia and Marina; grandchildren Sarah, Alyona, Nikita, and Tony; and great-grandchildren Katy and Arian. He was also loved by many close friends, extended family, and in-laws.

David was born in Pittsburgh, PA on September 23, 1942. He graduated from Columbia University with a BS and MBA, and met his future wife Joyce, who graduated from St. Luke's Nursing College "across the street." Once they were married, David's career path took them to Corning, NY, where Phil joined the family; Amherst, NH where Tim joined them; then they spent 16 years in Pittsfield, MA. Joyce's quest for warm weather and diving took them to Orange Park, FL for 30 years, where Dad retired from Lafarge in Palatka, FL. He accomplished his dream of owning a company — a machine shop in Keene, NH for a short time. He chose to work for smaller companies during his career as an industrial purchasing agent, including Columbia Bicycles, which allowed him to take samples of the latest toys home to his sons after the annual Toy Show each year; Gowdy-Shandoff's, and Bicron Electronics.

David was an active camper and took several canoe camping trips with family and friends to the Allagash River in Maine and other exotic places. He was an Eagle Scout and was a scout leader and sustaining member for years. He was an avid game player, including Hearts and Scrabble. He equally enjoyed a quiet weekend at home (installing a dishwasher or other projects "on the list") or a hike down into the Grand Canyon. He loved to cook and tend the garden, often picking fresh tomatoes for dinner once arriving home from work.

David was committed to social action work, including participation in the Fresh Air Fund, hosting a 1980 Presidential Candidate's campaign team at the family home, and hosting an International Student exchange student. More recently, he taught English to immigrants; participated and led discussions with the Jacksonville Human Rights Commission; dedicated countless hours to Wage Peace, and tirelessly contacted his Senators' offices to advocate for legislation he felt was important. He found active fellowship with his chosen faith, the Unitarian Universalist Church, in three of the communities where he lived.

David was challenged by three different cancer diagnoses since 2013, and an untreatable lung infection in 2023. He lived his life to the fullest even despite his medical issues: A year after his first cancer, he marched with Joyce in a Martin Luther King Jr. parade. A year after his second, he rebuilt a wood chipper, chipped brush from the yard, and placed the chippings around the yard. He was determined to stay in their house until he couldn't and moved to an Independent Living Facility with Joyce earlier this year — with stress on the word *independent*.
