#### **Call to Order**

The annual meeting of Buckman Bridge Unitarian Universalist Church was held on May 19, 2024. It began at 12:00 pm and was presided over by Board President Chuck Smithers, with Madeline Sims as Secretary.

#### **Review Fire Escape Plan**

Cindi Jorgensen reviewed the church's fire escape plan and where the fire extinguishers are. She also pointed out where the Automated External Defibrillator (AED) device is. The PA system will not work when fire alarms are going off, so it is important to know where the exits are. If children are in RE classes, their teachers will escort them outside so any parents/caregivers of the children will meet them there rather than going into classrooms to get them.

#### **Establish Quorum**

There are 147 Members. The quorum for this meeting is 25%, or 37 Members. There were 16 proxies submitted and 52 Members in attendance. The quorum was met with a total of 68.

#### **Approval of Minutes**

The minutes from the May 21, 2023 meeting was distributed to the congregation in the meeting notice. The floor was open for any Member to offer corrections. Since there were no corrections proposed, the minutes were approved as distributed by unanimous consent.

#### President's Report presented by Chuck Smithers, Board President

Chuck thanked all the church's volunteers for their hard work in keeping the church community going. The church has gotten stronger after the pandemic. Chuck thanked Board and Committee Members, even those without a chairperson. He also gave a special shout out to the Worship and LRE Committees for providing quality worship services and religious education programs. Chuck commented that the facilities are well kept and thanked those volunteers who keep the young building in good shape.

#### **Nominating Committee Nominations**

On behalf of the Nominating Committee, Chuck Smithers presented the following nominations for the Board of Directors:

- Secretary Kristina Altes
- Trustees Elizabeth DeCoux, Don DeStephano, and Nathaniel Samuels (all 2-year terms)

The Nominating Committee submitted Helen Meatte to serve on the Nominating Committee for a 2-year term while Kris Kines and Linda Mowers will complete their second year of their elected 2-year term this upcoming fiscal year.

#### **Elections**

All elections were uncontested, so bylaws specify that elections be done by acclamation. There were two votes held for both the Board of Directors and the Nominating Committee. Both votes were unanimous.

#### **Treasurer's Report** presented by David Prohofsky, Board Treasurer

David reported that salary costs declined, since the church no longer has a minister, but have been rising over time because of the inflationary climate and the need to rely on paid employees over volunteers. He stated that the church has more than adequate reserves if needed in the coming year. Overall, the church is in a solid financial position, especially with investments. David thanked Pam Richards and Peg Christenson for their help in his transition as Treasurer. David shared he will include a quarterly report in the Journey with updates on the church's finances. He also encouraged Members to contact him with any questions.

#### **Budget**

- The proposed budget for fiscal year 2024-2025 was distributed to the congregation in the meeting notice.
- The Finance Committee Chair, Chuck Smithers, presented the proposed budget. Chuck thanked all members who pledged and reviewed the budget process. He reported that the proposed budget is about \$20K less than what was pledged last year. However, pledges still can be made during the year. He next reviewed the proposed budget: major expense areas are payroll, insurance, and other functional areas like facilities.
- Opened the floor for questions:
- Carl Moody expressed disappointment that funding the Capital Repair & Replacement (CR&R) is not included in the budget. Chuck replied that he still expects to fund the CR&R next year, even if it is not in the budget, and that the church has consistently funded it in the past. Last year, the church did not budget for the operating reserve

- budget for the operating reserve but still had enough funds to cover it.
- o David Dean asked if the budget includes paying the UUA dues. Chuck responded it is under the board budget in the line item UUA APF (Annual Program Fund). Pam Richards further clarified that the UUA APF is calculated based on the annual operating expenses.
- After questions, Chuck called for a vote to approve the budget. Voting was done by raising voting cards. The budget was approved unanimously.

#### **Words from the Floor**

David Christenson thanked Chuck for serving on the Board for three years (one as Vice President and two as President) and appreciates that Chuck is taking over as Finance Chair. David also expressed appreciation to the new Board Members who are willing to serve.

### **President's Report: Fiscal Year 2024-2025**

This was a year of discovery for many of us on the Board. Even though there was ample leadership experience and lots of passion, we had a bit of a journey. Thanks to David Prohofsky, Don DeStephano, Peg Christenson, and David Christenson for their institutional knowledge and help. Also, a shout out to Chuck Smithers and Kris Kines for their advice and encouragement to this president.

The Board envisioned building our programs and enabling our volunteers to persevere in their very demanding work. To this end, we hired a part-time bookkeeper, increased the job responsibilities of the Office Administrator, hired babysitters, and an as needed sexton. These actions have helped to relieve some of the tasks required in the respective fields.

As far as facility and safety improvements, we had a survey by JSO with recommendations for enhancing safety. Our rooms are now equipped with door locks and barriers, communication is enhanced and camera upgrades are in progress.

Our outside enhancements are well on their way, under the leadership of our new GroundscrUU. We now have sprinklers, and should be well on our way to having plantings by the time of the annual meeting. We are also in the planning stages for a necessary retaining wall to keep our walkways from eroding.

This year has been spiritually challenging due to the anxiety caused by the changes in our national leadership, and the anticipated and already implemented policies that are a threat to our UU values. This has run a thread throughout our worship, our religious education, our pledges, and our committees that deal with social action. Our little community has afforded its members and visitors a safe place for expression and being our true selves.

I would like to highlight our events this year that brought us together for a good time! We have tremendous volunteers that arranged Halloween, Thanksgiving, Holiday, and Easter events. A bit of fear here naming names in case I omit someone, but I hope they all know how they are appreciated.

Our BBUUC rocks with its infusion of new members, and we are outstanding in attracting families with kids! I am confident that we have a larger proportion of little UUs than many churches, but that does mean we need a greater commitment from our members to give a bit of help with our programs.

So! Onward! We are making attempts to improve our practices to promote inclusiveness in our sanctuary. Our Rainbow/Welcoming Congregation Ministry has been resurrected and READI is indeed ready to lead us in our anti-racism efforts. To fulfill acting on our values, we surely need a few good folks to help us recommit to Social Action and ICARE.

# Affiliated Community Minister's Report: Fiscal Year 2024-2025

On 6/19/24 the Board and I renewed our Covenant of Affiliation for the period 7/1/24 to 6/30/25. In accordance with our Covenant, I remain in good standing with the Unitarian Universalist Ministers Association ("UUMA"), a member of the UUMA's Community Ministers chapter, and in full fellowship with the Unitarian Universalist Association ("UUA").

I continue my role as Spiritual Support Services Coordinator for Baptist Health System of Northeast Florida ("BHS"), with a focus on spiritual wellbeing for BHS team members across 6 hospitals and 5 freestanding emergency departments. My job is expanding to include more community outreach. Over the past 12 months my work in this role has included:

- development of bereavement support group curriculum and facilitator training
- plan and execute our 2024 Restorative Chaplaincy Conference in September 2024
- education re: chaplains as clinical care provider members of interdisciplinary teams
- developing and leading resiliency workshops for managers and leaders
- invocation for public grand opening of Nassau Crossings freestanding ED
- continue to serve as an on-call chaplain for BMC Nassau and Nassau Crossings ED
- training and didactics with clinical pastoral education (CPE) interns and residents
- develop and coordinate symposiums on grief, ethics, and moral injury
- joined the board of InterfaithJax (formerly the Interfaith Center of Northeast Florida)
- will be presenting with other department leaders at the annual conference of the Association for Professional Chaplains in June 2025

In terms of direct services to BBUUC, and in accordance with our Covenant, I have:

- Preached the post-2024 election service at BBUUC (11/10/24) and led a memorial service/ celebration of life service for one BBUUC member.
- Continued to consult with Claudia Marshall and the READI Ministry Team.
- Continued to consult with the Healthy Congregation Ministry Team, including planning for our 2025 Workshop: Conflict Resolution as a Spiritual Practice (5/3/25). Our HCMT common read was On Repentance and Repair: Making Amends in an Unapologetic World (by Danya Ruttenberg). I also studied the work of Amanda Ripley in High Conflict: How We Get Trapped and How We Get Out, as well as the work of Dr. Les Carter's #teamhealthy YouTube channel, "Surviving Narcissism."

As a board certified chaplain I am required to complete 50 continuing education credits each year. This year my continuing education includes:

- Continued progress towards a Certification in Grief & Bereavement through the Center for Loss & Life Transition (anticipated 5/2026, 2 of 5 classes completed).
- Earned a Certificate in Moral Injury (MI) through the Shay Institute for Moral Injury.

Finally, as a professional religious leader and fellowshipped UU minister I remain attuned to and informed about denominational matters. Since being ordained in 2010 I have faithfully served as a voting delegate at 11 of the past 14 UUA General Assemblies (GA), including the 2024 GA during which a majority of delegates (80.2%) approved an amended version of Article 2 of the UUA Bylaws, following the three year amendment process required by our Bylaws.

No vote has felt as significant to me as the 2024 vote that refreshed Article 2 with our Shared Values and Covenant. Article 2 has been revised 4 times over the past 64 years (since the merger of the Unitarians and the Universalists). Not only is such review and revision embedded in the UUA Bylaws, their evolution is an appropriate and reasonable expectation for our non-creedal, covenantal, living faith tradition. In my memory no past issue has similarly excited the passions and participation of thousands of UUs, and nothing has matched the efforts and successes of the UUA to engage UUs across the land in both the Article 2 conversations and the democratic process required to change our UUA Bylaws. Having worked for several years on the UUMA Board with Rev. Cheryl Walker, chair of the Article 2 working group, I trust her implicitly and know firsthand of her integrity, her UU theological understandings, and her love for our faith – all of which grounded her as she led the most diverse Article 2 working group in the history of our Association.

The saying is, "as we know better, we do better," and each change, each evolution, has reflected our understanding of what it means to name and to live our shared UU values. As my colleague the Rev. Victoria Safford said before the final vote, "However we vote, we put love at the center, unflinching, insistent: this free faith we so cherish reveres the past and trusts the dawning future more. We believe in evolution—unfolding always, not unraveling—and revelation is not sealed."

As I continue to witness the contempt and divisiveness present in our national landscape, I am deeply grateful and incredibly proud to be part of a religious tradition that can engage in robust and respectful dialogue, exploration, discovery, and declaration while simultaneously holding reverence for all we've come from and hoping (and committing) to all we yet may be, together. *Revelation is not sealed.*

I've been a UU since 2016 and was a member of UU fellowships in Greeley, Colorado, and St. Augustine before joining BBUUC in 2022. I grew up in Brooklyn, NY, and have lived in California, Oregon, Washington State, Hawaii,

Central NY, and Colorado. I'm retired from an eclectic mix of jobs, including freelance writing and proofreading, newspaper reporting, and nonprofit work. Special interests, mainly from life experience, include adoption, racial issues, disability, bereavement, and child welfare. I love to read—mostly nonfiction—and take long, long walks.

I met my husband at a Catholic high school dance in 1968; we were married for 30 years before cancer took him in 2004. We have two sons, two daughters, and three grandsons. Our oldest son died in a swimming accident in 1994 when he was 17. His death sent me on a deep spiritual search. I began reading about other religious traditions and eventually began to feel that I had outgrown any one religion and its beliefs. At the same time, I felt that the Catholic Church was going backward from the progress made after Vatican II, becoming more and more conservative. I continued to go to Church and even worked for the Church at one point, but my heart wasn't in it.

I left the Roman Catholic Church for the Ecumenical Catholic Communion (ECC), but even that seemed too dogmatic. I kept going back in my mind to UU -- I had attended a funeral at a UU church in the 1980s and remembered being struck by the lack of dogma and the casual, accepting ambiance. I began researching UU and was impressed by its respect for all beliefs, lack of specific tenets, and emphasis on social justice. When I joined UU it felt like coming home, like I was among people who think outside the religious "box." I'm thankful now to be part of BBUUC and to have this opportunity to be on the nominating committee.

I was born and raised in Jacksonville. As a child I attended (not so regularly) the Episcopal church and converted over to the United Methodist Church when I met my wife to be (Julie) in high school. After

finishing college at FSU in 1973, we moved to Orange Park and became long-time members of the Orange Park United Methodist Church until the political climate there changed. We found it necessary to look for a new church home, and we were lucky to find BBUUC in 2019.

I am a certified public accountant but have spent most of my professional career in the health care industry as an administrator and consultant. I sort of retired in 2013 but have kept active doing consulting and working with several nonprofit organizations in the area and nationally, usually in a financial capacity. I enjoy the opportunity to volunteer my time and to give back to the community in this way.

At BBUUC I started volunteering immediately upon joining the church. I was Vice President of the Board in 2021-22 and served as President 2022-24. I now serve on the Membership Committee and the Grounds CRUU. I find the community we have at BBUUC to be what makes me happy and energized.

### Treasurer's Report to Congregation as of March 31, 2025

#### **Highlights**

Statement of Financial Position as of Mar. 31, 2025 vs Mar. 31, 2024 (Prior Year)

BBUUC remains in a strong financial position. We have no debt. Our bank balances have significantly decreased, as we took proactive measures to improve the returns on our reserves. We transferred \$140,000 from our bank accounts to our investment account to take advantage of high money market interest rates and to be prepared to invest in CDs to secure these higher rates in a manner that will not undermine our cash flows if the market turns towards lower interest rates.

We spent approximately \$7,000 to update the furniture in our meeting rooms, and a further \$1,000 to upgrade the security of our building with new locks from our Capital reserve. Despite this, we have been able to grow the Capital Repair & Replacement (CR&R) reserve fund, that ensures our ability to maintain and repair our building and other physical infrastructure, to approximately \$138,000 as of 3/31/2025. This is an improvement of approximately \$29,000 toward our desired balance of \$150,000.

We have not needed to transfer any money from the Operating Reserve for FY 2024 operations. Our spending has increased, but not so much as to exceed our donations. Our current projections are to write off approximately \$5,000 in pledges, but we still expect to be very close to having revenues roughly equal to our expenses for the year.

Our Fixed Assets are unchanged, and we have no Long Term Liabilities.

The Congregational Growth and Development Reserve was not drawn on, with interest growing the balance to \$92,535. \$1,250 was disbursed from the Emergency Caring Fund, leaving a balance of \$4,291. Endowment Net Assets increased by more than \$11,000 due to the previous strength of the financial markets. We note that current turmoil may reduce our endowments for the near term.

Statement of Financial Activity July 1, 2024 to Mar. 31, 2025 vs Prior Year to Date

Total Revenue is down by approximately \$17,000 year to date. This is mostly a drop off in pledged donations.

# Treasurer's Report to Congregation as of March 31, 2025 (Continued)

Total Operating Expenses are up approximately \$12,000. We spent approximately \$1,000 for our facilities, but that has been offset by over \$7,800 in payroll, and nearly \$2,000 for a bookkeeper. Payroll costs will continue to rise as we are hiring employees for services lacking volunteer support, and increasing wages in response to information about UUA guidance on appropriate wage scales. Payroll costs will be higher in the next fiscal year reflecting a full year of the pay increases. Board expenses also increased by nearly \$3,000, driven by expenses for our DLRE training. The expense increase also reflects the Board's investment in our Stewardship campaign.

Budget vs. Actual Expenditures as of March 31, 2025

Total Revenue is 78% of budget for 75% of the year.

Total Operating Expenses are 69% of budget for 75% of the year.

As of the end of March, we have a residual of \$12,000. If we do end up with a positive balance at year end, since a CR&R contribution was not budgeted, any positive balance will be transferred to the CR&R reserve to bring it closer to the goal of \$150,000.

#### Mission:

The Mission of the READI Ministry is to educate BBUUC in effective and evolving anti-racism and anti-oppression work. Through education, discussion, reflection, and community work we will deepen our understanding of racial equity, accessibility, diversity, and inclusion and empower our community to change the world, beginning with ourselves.

### **Major Initiatives and Accomplishments:**

- Participated in our General Assembly and held discussions on the events, observing the implementation of Article II. We will continue this work with enthusiasm and welcome the changes that make us more human.
- Collaborated with Religious Education to host a congregational discussion featuring Rosemary McCoy from the Harriet Tubman Freedom Fighters, who discussed voter suppression. Additionally, we assisted her with sending postcards to formerly incarcerated/ returning citizens to help them regain their right to vote.
- Dedicated our new Banned Book Library on March 23, 2025. The library was physically installed on the front porch in October. This little library caters to young adults and adults.
- Banned Book Discussion group started in January. We are following through every month by discussing books that are challenged in our community. Books discussed or planned include *Fahrenheit 451*, *How to Be an Anti-Racist, The 1619 Project*, and *How to Stand Up to a Dictator*.
- Dr. Rudy Jameson, Executive Director of the Jacksonville Human Rights Commission, spoke to our congregation about the work of the JHRC. We plan to work with him in the future to create programs for our community.
- Twenty petitions were collected in support of a constitutional amendment initiative to expand Medicaid in Florida that would be on the 2026 ballot. We plan to collect more.

**Worship Mission Statement**: To deepen the spiritual journey of our congregation by creating and presenting shared worship experiences that center on Unitarian Universalist Theology, our Values, and the Inspirations of our faith, all of which call us to our better selves. (rev. 7-18-24)

#### **Vital Signs**:

- We are a team of trained and experienced worship leaders who collaborate effectively. We are responsible for planning, creating, and conducting the weekly worship services for our lay-led congregation, which a professional minister would traditionally perform.
- Worship has weekly meetings every Thursday night. We hold special meetings as needed for training and special service planning.
- Speakers and sermons are scheduled, providing the anchor for our Worship services. We subscribe to Soul Matters Sharing Circle, a network of UU congregations that follow the same monthly themes, sharing materials, support, and resources for Worship, Small Group Ministries, and Religious Education programs. The network provides Worship with relevant choices of liturgy, inspirations, and sermons written by professional, fellowshipped UU ministers who allow us to present their sermons to our congregations and create our own services around them.
- In addition to our Soul Matters themes each month, we also integrate an occasional recorded sermon that we receive through the UUA's Sermon of the Month series, featuring a sermon presented by various members of the UUA Congregational Life staff, other UUA staff groups, or guest ministers from around the country. This allows us to hear the prophetic voices and wisdom of many excellent religious professionals and leaders within our faith tradition.
- Participation of BBUUC member musicians and live guest musicians from the larger community are engaged for Worship with the help of Lynn Wadley as the scheduler. Music continues to be an essential element of our services, and we have been so fortunate to have featured a wide array of excellent musicians.
- We are also very fortunate to have member Dr. Gary Smart, pianist, as our volunteer accompanist, who also provides us with his own performances and often accompanies some of our guest musicians and member musicians. We are also grateful for Eileen Morrison, who has generously stepped in to serve as accompanist whenever Gary takes an occasional day off or is otherwise unable to attend.
- Periodic "family" Worship services are conducted for special holidays, ceremonies, or Worship that involve all ages in the congregation. Worship collaborates with our DLRE, Beth Curtis, for family services and our Time for All Ages throughout the church year.
- Worship services are recorded, edited, and posted on our YouTube channel.

### **Worship Committee (continued)**

### **Major Initiatives and Accomplishments:**

- A commitment to keep Worship focused on sermons that center our theology, values, UU
  initiatives, and inspirations, including the sacred, secular and scientific. We also incorporate
  services of notable celebrations, holidays, and holy days, including Water Sharing, Christmas
  Eve, Easter, Flower Communion, PRIDE month, and recognitions of other holidays within the
  individual services.
- We strive for inclusivity in lifting the voices and concerns of marginalized people in our services, including liturgical elements, music, and sermons from diverse sources.
- We are committed to supporting the annual renewal of our Welcoming Congregation
  Status by incorporating Welcoming Worship Services into our worship calendar. We also
  support our renewal by recognizing and celebrating the Welcoming Days of Observance
  (Days and seasons that are important to LGBTQ+ communities) in our worship services
  throughout the year.
- We worked with the Board and the Stewardship team to integrate our stewardship theme, "InvestFest," into the March services, including a new "Founders' Day" service, and another service featuring a sermon written and delivered by Jennifer Bacmeister on *Generosity*.
- We have followed the progress of our upcoming new UUA Virtual Hymnal which will roll
  out this year in June at General Assembly. We have discussed how we will utilize it in our
  worship services.
- We organized and conducted the annual poinsettia sale for decorating the chancel and sharing the names that the plants were in memory of on Christmas Eve.
- The worship team has put together a Worship Survey that will be distributed to the congregation in the coming weeks, before the end of the fiscal year.
- We are committed to the continued education of our worship team members and are
  focused on creating, improving, and evolving worship for our faith community. We also hold
  retreats, group outings, and social gatherings, fostering team bonding, morale-boosting,
  and enhancing communication. Since we all work so closely together throughout the year,
  these activities create a relaxed and informal setting where team members can connect
  personally, build trust, and develop a strong camaraderie.
- Plans are underway for a new sermon series focused on various World Religions or Religious Traditions through the lens of religious pluralism. The series will begin this summer and run through the next fiscal year. We will be bringing in local clergy from various religious communities in our area to present sermons on their faith traditions, allowing us to learn how we might be similar and different, as well as developing skills for engaging views different from ours. Rev. Carmen Emerson, BBUUC's Affiliated Community Minister, is a new Board member of Interfaith Jax and is helping us find and meet speakers who will participate in our series. We hope to designate one Sunday a month as "Interfaith Sunday."

In memory of Brian Sibson, a man whose life was woven with threads of innovation, humor, and an unyielding spirit. "Everything is a mythical, cosmic battle between faith and chance," a sentiment from one of Brian's favorite films *Children of Men*, resonates deeply in Brian's life. A brother to Tim, Jean, Laura, and Sandra; a father to David, Chris, and Lara; a partner to Carole, Brian loved the people in his life with his whole heart. His brilliance illuminated every corner of his life.

Brian's love for 1950s sci-fi was not just a hobby but a lens through which he viewed the world — a world where creativity knew no bounds and imagination took flight. A comedian and philosopher, one of his best friends recalls that Brian possessed a mind akin to a supercomputer, with a photographic memory that captured every detail of his vast pursuits. There was no challenge too great for him, no problem too complex to solve. From his innovative designs — a semi-prone bicycle and Hunter Fans' ceiling fans — to his thrilling ventures like the electric race car that raced at Atlanta Motor Speedway, Brian's creations mirrored his boundless ingenuity.

Yet, despite his accomplishments, Brian faced a relentless adversary in the form of Myasthenia Gravis — a rare, cruel disease that tested his strength and resilience. Despite enduring its debilitating effects — moments where swallowing, breathing, or even opening his eyes became monumental tasks — Brian fought back. His battle was not just against illness but against the limits imposed upon him. His recent endeavor — the meticulous restoration of a 1950s Comet trailer — stands as a testament to his enduring passion and vision.

Those of us who knew him will remember his larger than life personality and the marvels he created. His life was indeed a mythical battle — a testament to the enduring struggle between faith in possibility and the unpredictability of chance.
